Lesson 3 Recap – Courts of Heaven



From Sinai's Law to Zion's Grace (Hebrews 12:18–24)

- **Sinai (Old Covenant):** Fear, trembling, and law; God “marrying Israel” through covenant vows.
- **Zion (New Covenant):** Intimacy and relationship, access to Jesus the Mediator, and the blood that speaks better things.

Takeaway: We no longer stand under legalism at Sinai but in covenant relationship at Zion.



Courts of Heaven: Legal Access to Divine Justice

- Everything is recorded in the Books of Heaven.
- Believers can present repentance, annul demonic claims, and seek verdicts aligned with God's will.
- Avoid “repentance loops”—trust what's already recorded.



A Spiritual Dimension, Not a Formula

- Courts are not a formula but a dimension of the Spirit.
- We live in two realms—earth and heaven—by faith (John 3:13; Eph. 2:6).
- The Father's house has spiritual “rooms” we access now through Christ.



Governmental Role of Zion

- Ecclesia functions as a house of prayer and legal representative before God.
- Judgment in heaven precedes warfare on earth (Rev. 19:11).

- The praying church carries the governmental role Lucifer once held.

Spiritual Trading Floor & Witness Through Tithing

- Approaching God always involves exchange: weakness for strength, ashes for beauty.
- Tithing acts as legal testimony in the Courts (Hebrews 7:8).

Confession as Legal Testimony

- To confess (*homologeō*) means to give binding testimony in agreement with heaven.
- Speaking what heaven is saying becomes legal evidence that manifests on earth.

Sinai vs. Zion	Sinai = fear/legalism; Zion = intimacy, grace, and access
Judicial Prayer	Present repentance, annul accusations, receive verdicts
Not a Formula	Courts = dimension of Spirit, not method
Dual-Realm Living	Believers function in heaven & earth
Ecclesia's Authority	A remnant can represent nations legally before God
Spiritual Trade	Tithes & offerings act as legal evidence
Confession/Testimony	Agreement with heaven manifests on earth
Cultural Transformation	Courts shift nations into divine order

Even them I will bring to My holy mountain, and make them joyful in My house of prayer. Their burnt offerings and their sacrifices will be accepted on My altar; for My house shall be called a house of prayer for all nations.

Ezekiel 28:14 (NKJV)

“You were the anointed cherub who covers; I established you; you were on the holy mountain of God; you walked back and forth in the midst of fiery stones.”

Genesis 4:9–11 (NKJV)

Then the Lord said to Cain, “Where is Abel your brother?” He said, “I do not know. Am I my brother’s keeper?” And He said, “What have you done? The voice of your brother’s blood cries out to Me from the ground. So now you are cursed from the earth, which has opened its mouth to receive your brother’s blood from your hand.”
