Main Theme

How to Present a Case in the Courts of Heaven

Breakthrough doesn't come by fighting demons on a battlefield, but by **silencing accusations in the spirit realm** and presenting evidence before the Righteous Judge.



Four Main Parts



The Accuser & the Court (Rev. 12:10–11)

- The enemy functions as a *legal accuser*.
- We overcome by the **blood of the Lamb**, **word of testimony**, and **not loving our lives unto death**.



Silence the Accuser with the Blood

- Repentance + walking in the light keeps the blood cleansing us (1 Jn 1:7; Heb 12:24).
- Apply God's statute of limitations: only 3–4 generations are admissible (Ex 20:5; 1 Tim 1:4).



The Word of Your Testimony = Presenting Evidence

- The blood plays **defense** (dismisses cases).
- The testimony plays **offense** (presents your case).

Evidence the Court Responds To

- You must bring evidence, not just passion.

Five Ways to Present Your Case

1. From Your Book (Destiny + Grace)



You'll know it's your purpose when:

- You **enjoy** it.
- You discover **gifts** in it.
- It bears **fruit & success**.
- You can **make a living** from it.
- The **right people** favor you.

2. Prophetic Words

- Name the prophet and declare what was spoken (1 Tim 1:18; Dan 9).

3. What Jesus Accomplished

- Present His finished work: forgiveness, healing, peace, deliverance (Isa 53:4–5).

4. Promises of Scripture

- Quote His promises as precedent (Ps 41:1–3; Matt 5:23–26).

5. Offerings that Speak

- Offerings carry a testimony—when given with a pure heart, they speak in your favor.
